- Cancellations can be fully reimbursed until the 15 February 2022, and all payments reimbursed except GRITCHEN and FFCT insurances.
- Bookings are dealt with in order of sending of payment, defined by postmark or date of bank transfer (even in the case of digital booking), to take account of postal delays, especially for foreign members and those with internet connection. A waiting list will be established once all available places are filled.

Special conditions

Participant only service.

The cost of a sejour is not limited to room and board. As well, our hosts charge us for rooms for bike storage, for the shop and for rooms with sound systems for our presentations, talks and functions. Often the welcome and farewell drinks are charged for by the number of people present. Amongst other expenses there are the production and printing of the guide book, the trombinoscope and posters, as well as the preparatory work in visting the accommodation, preparing the rides, and reconnaissance on the ground.

For a sejour like Cavi di Lavagna, this adds up to several tens of euros per participant. Up to 2019 these incidental expenses were borne only by the members staying at the official accommodation and were included in the « Full Board » fee. To be more equitable, the CA decided to redistribute these expenses amongst all participants to the stays and we have therefore introduced, since the Chessy trip, a "**Participant Only service**" which must now be subscribed to by all members participating in the trip (whether they choose full board, the 7-dinner package, or whether they arrange their own board and lodging) with the exception of associate members only. The subscription of this package will give them access to the booklet of the stay (except for the associate members), to the drinks, to the accommodation's facilities (bar, bike store etc) and to the other activities. This service includes costs linked to the tourism charter of the Chambre des Associations. Associate members, accompanying Participant Only members, are kindly invited to our welcome and farewell parties, but are not covered by the insurances undertaken by the Club for the sejour.

For legal reasons, the stays are only accessible to members of the Club. Please make sure that you are **up to date with your membership fees** before sending your registration form.

Cancellation before the closing date for bookings.

You may cancel and be completely reimbursed (without non-FFCT insurance) if you let us know before the closing date for bookings

Cancellation after the closing date for bookings.

If you cancel after this date :

- With the GRITCHEN cancellation/repatriation insurance you will be compensated according to the conditions of contract no.6181 (see below) ;
- **Without the GRITCHEN cancellation/repatriation insurance you will eventually reimbursed according to the current conditions, that is, to the sum that we can recoup from our hosts less an exclusion of 50€.**

CANCELLATION/REPATRIATION GUARANTEES

Code du Tourisme Article R211-4 (Décret n°2009-1650 du 23 décembre 2009) à l'alinéa 12 :

12° Information concerning the option; subscription to an insurance contract covering the consequences of certain cancellation cases or of a contract of assistance covering certain special risks, notably the costs of repatriation in the case of illness or accident.

Guarantee Cancellation – Interruption – Extension COVID Contract n° 6181

This notice is available on our site in the section Séjours – Séjour Ubaye 2021. For those without an internet connection, it can, upon demand, be sent by post

The insurance takes effect from the date of your booking, by the séjours officer of the Club des Cent Cols.

From that time, in the case of cancellation covered by insurance, the member will contact the insurer directly for their compensation (which will not include either the cost of the GRITCHEN insurance, nor that eventually of "non FFCT" insurance). The Club will be kept informed of the process. If you cancel for any other reason, you will eventually reimbursed according to the current conditions, that is, the sum that we can recoup from our hosts, less 50€.

COVID 19 obligations

For the moment the health provisions imposed by the Italian government are similar to those of the French authorities, that is, social distancing, wearing of masks in communal spaces and frequent hand cleansing with hydroalcoholic gel.

The prices that the Club has negotiated with our hosts are based on double rooms, with a few single ones offered subject to a supplement. If the health situation worsens in the future, this scheme may have to be altered, particularly for non-couples sharing one room, and would be carried out as follows :

- Couples, and two people wishing to share a room and included on one Booking Form, will be placed in double rooms, as originally intended.
- Participants having booked a single room will be placed in a single room, as originally intended.
- Other participants will be placed, one each, in double rooms, to comply with health requirements, and may be required to pay a supplement of 100 euros for the week (the same sum as the single room supplement).
Eventually, some may need to be placed, if possible, in a third hotel, if the resources available to the Club permit this.

In this last case, the participant will have two options :

- Accept the added cost due to health requirements and pay the 100 euros.
- Cancel their booking, and use the cancellation insurance that they have taken out to be reimbursed. From this reimbursement, 37.64 euros will be taken by the Club for resolution costs.
