Special conditions

Participation towards organisational expenses.

The cost of a holiday stay is not limited to just the reservation of rooms and meals. In addition to these services invoiced by the establishment (or the establishments) that is accomodating us numerous other expenses can be added. Thus often the host centre will invoice us in addition for the costs of the room (or the rooms) made available (for keeping the bikes, for the Club Shop, for a large room with audio-visual facilities for presentations, for welcome drinks, speeches etc). In many cases the welcome/departure drinks are invoiced separately according to the actual number of participants. Amongst other expenses we can find the production and printing of the booklet, the trombinoscope and the displayed maps; costs incurred in preparing the stays (visiting the establishments when this is necessary, preparing and reconnoitring the circuits including in situ visits etc.), etc

For a stay like that of Sare for example all this represents several tens of Euros per participant. Until 2019 these costs where covered by just those members booking accommodation and included in the corresponding tariff. In the interests of fairness the C.A. took the decision to spread these costs over all of the participants of stays and we have therefore put in place, from 2020 onwards, a "**Participation towards organisational expenses**" which must now be paid by all members participating at a stay (whether they choose Full Board, the 7 dinners package or are boarded and lodged by their own means) except for associate members only. Booking this item gives you access to the booklet (except for associate members), to the welcome/departure drinks, to the facilities of the centre and other activities. This item includes the costs related to the Tourism certification at the "Chambre des Associations". Associate members accompanying these non-resident members are invited free-of-charge to the welcome and departure drinks but are not covered by the insurances.

Stays (séjours) only being accessible, for legal reasons, to Club members, please make sure that your Club subscription is up-to-date before sending your Booking Form.

Cancellation before the closing date for bookings

You may cancel and be completely reimbursed (other than non-FFCT insurance) if you let us know before the closing date for bookings.

Cancellation after the closing date for bookings

If you cancel after this date :

- With the GRITCHEN cancellation/repatriation insurance you will be compensated according to the condition of contact n° 6181 (see below)
- Without the GRITCHEN cancellation/repatriation insurance you will eventually be reimbursed according to the current conditions, that is the sum that we can recover from our hosts less a deductible of €50

This notice is available on our site in the section Sejours - Sejour Sare 2022. For those without an Internet connection it can, upon demand, be sent by post.

The insurance takes effect from the date of your booking by the séjours officer of the Club des Cent Cols.

From that time, in the case of cancellation covered by insurance, the member will contact the insurer directly for their compensation (which will not include neither the cost of the GRITCHEN insurance nor that, eventually, of "non-FFCT" insurance). The Club will be kept informed of the process. If you cancel for any other reason, you will eventually be reimbursed according to the current conditions, that is the sum that we can recoup from our hosts, less \in 50.

COVID 19 Constraints

Since 15 January 2022, all people older than 18 years and one month must have received their **booster injection according to the stipulated dates in order to maintain an active vaccination certificate** through the "pass sanitaire". Outside of the designated due-dates their previous vaccination certificate is considered to have expired and is no longer valid.

The "vaccination pass" is in force since the 24 January 2022 and concerns all people of 16 years of age or more.
